



Play Moore Soft Play Hire Agreement & Disclaimer

These instructions are here to help your children have fun and ensure their safety.

Please read and follow the safety and hire instructions below.

1. It is the responsibility of the person who is hiring the soft play, bouncy castle, sleepover tents, party tables, sweet stand and/or light up numbers (“**equipment**”) to ensure that all possible steps are taken to avoid injury to users or damage to the equipment.
2. A responsible adult must supervise at all time.
3. No adults are allowed on the equipment. It is strictly prohibited for both children and adults to be on the bouncy castle at the same time.
4. Always ensure the bouncy castle is not overcrowded and limit numbers according to the age and size of the children using it. It is advised that children of mixed ages should not use the bouncy castle at the same time.
5. The bouncy castle has a maximum age limit of 10 years.
6. Do not allow children or adults to become boisterous, push, collide, fight or behave in a manner likely to injure or cause distress to others.
7. To avoid choking and mess, no food, drinks or chewing gum to be allowed on or near the soft play or bouncy castle.
8. All footwear, glasses, jewellery or any other hard, sharp or dangerous objects which could cause damage to other children or the equipment must be removed before using.
9. No face paints, party poppers, colour streamers or silly string to be used near the bouncy castle.
10. No face painting or shoes to be allowed within the soft play area.
11. Smoking and barbecues are not permitted near the bouncy castle or soft play.
12. No pets to be allowed on or near the equipment.
13. Climbing, hanging or sitting on the walls or beams of the bouncy castle is dangerous and is not permitted.
14. Ensure that no one with a previous medical history including pregnant, back or neck problems is allowed on the bouncy castle.

15. If the bouncy castle is not being used for any part of the day, please switch off the blower at the mains.
16. Do not allow anyone to be on the bouncy castle during inflation and deflation or whilst deflated.
17. Please warn children of the tie down points to avoid injury.
18. The bouncy castle should not be used if the weather becomes wet or windy. In the event of heavy rain, switch off the bouncy castle at the mains. Any wetness, including bubbling (which is normal), can be dried with a towel.
19. Should the equipment fail for any reason, please ensure all users get off immediately.
20. No unauthorised person should move the equipment and bouncy castle or tamper with the electrical equipment.
21. Once the equipment has been placed by Play Moore, it is strictly prohibited to move to avoid injury or damage.
22. The equipment must be returned in an acceptable condition, i.e. clean, unsoiled, undamaged. If it is badly soiled or damaged, the hirer will be expected to pay an additional charge to cover the cleaning costs and our loss of earnings if the equipment is rendered out of commission for any reason.
23. We are insured with full public liability insurance against the failure of our hire equipment, any claim is subject to an excess which the hirer concerned would be liable for.
